6. FOR MOSCOW: EMBASSY MAY WISH TO NOTIFY MFA THAT ATTENDANCE OF WITNESSES FROM ISRAEL AT ABOVE PROCEEDINGS HAS BEEN REQUESTED BY INS. VANCE
