2. PLEASE ASK MFA WHETHER SOVIET AUTHORITIES CAN LOCATE LEIB WAGENHEIM AND WHETHER HE WOULD BE WILLING AND ABLE TO COME TO US TO TESTIFY. PROCEEDINGS IN BOTH CASES ARE SCHEDULED TO RECONVENE IN JANUARY. VANCE
