SOVIET ARCHIVES. LET US KNOW IF OTHERWISE. 6. STATE 20457 TRANSMITTED A LETTER FOR SOVIET LEADER OF "MARINE MAMMALS" PROJECT (02.05-61) UNDER THE ENVIRONMENTAL AGREEMENT, WHICH APPEARED TO CONTAIN A SERIOUS IMBALANCE IN ACCESS TO INSTITUTIONS AND TO GEOGRAPHIC AREAS. WE HAVE NOT TRANSMITTED LETTER TO THE SOVIETS, BUT WE HAVE RELAYED THE MOST URGENT SECTIONS OF THE MESSAGE OVER THE PHONE. WE ARE CONCERNED THAT U.S. PROJECT LEADERS APPEAR TO BE MAKING COMMITMENTS TO HOST SOVIETS IN SAN DIEGO AND ALASKA, WITHOUT SECURING RECIPROCAL COMMITMENTS FROM THEIR SOVIET COLLEAGUES TO ALLOW VISITS TO AREAS OF INTEREST HERE. U.S. PROJECT LEADER RATHER TEPIDLY REQUESTS VISITS TO MARINE MAMMAL RESEARCH INSTITUTES IN MAGADAN AND VLADIVOSTOK, BUT IN VIEW OF PAST EXPERIENCE THESE PROBABLY WILL BE DIFFICULT TO ARRANGE. U.S. MIGHT HAVE BETTER CHANCE OF SUCCESS IF WE COULD LINK PROGRAM IN SAN DIEGO TO ONE IN VLADIVSTOK OR MAGADAN. THE 02.05 WORKING GROUP HAS EXPERIENCED REPEATED PROBLEMS OF ACCESS TO THE REMOTE AREAS OF THE SOVIET UNION (STATE 18635 AND MOSCOW 202 NOTED SOME OF THESE PROBLEMS). IN THE PRESENT INSTANCE SOVIETS HAVE APPARENTLY REJECTED U.S. REQUEST TO HOLD WORKING GROUP MEETING IN BAIKAL AREA.
