HAZNERS

1. DEPORTATION PROCEEDINGS AGAINST HAZNERS ARE NOW IN PROGRESS. AT THE HEARING, A QUESTION WAS RAISED REGARDING HAZNERS' SERVICE BEFORE 1943.

2. ACCORDING TO A HANDWRITTEN STATEMENT IN HAZNERS' SS FILE, HE SERVED FROM JULY 10, 1941 TO OCTOBER 10, 1942, IN A UNIT KNOWN IN LATVIAN AS THE "RIGA KAITILOS." THE STATEMENT IS DATED PAPLANO, 1943, 29 JULY, AND IS TRANSLATED INTO GERMAN UNDER THE CAPTION: LEBENSLAUF DES HSTUF. HAZNER, VILIS-ARVEDS. IN THE GERMAN TRANSLATION, THE UNIT IS CALLED THE "RIGAER SCHUTZMANNSCHAFT."

3. INS HAS ASKED THE EMBASSY TO OBTAIN ALL INFORMATION CONCERNING THE RIGAER SCHUTZMANNSCHAFT WHICH IS UNCLASSIFIED
