1. EARLY OCTOBER 23, MFA USA DIVISION FIRST SECRETARY PAVLOV ADVISED CONSUL THAT DOCUMENT REQUESTED REFTEL A HAS BEEN SENT BY COURIER TO SOVIET EMBASSY STOCKHOLM WHERE INS ATTORNEYS GEORGE PARKER AND ROBIN BOYLAN CAN CALL TO PICK IT UP.

2. FOR STOCKHOLM: DOCUMENT IS TO BE USED BY U.S. ATTORNEYS AT A DEPOSITION IN THE WAR CRIMES CASE OF VILIS HAZNERS, SCHEDULED TO BE HELD IN STOCKHOLD ON OCTOBER 25. PLEASE ADVISE MESSERS PARKER AND BOYLAN OF FOREGOING MESSAGE IN EVENT THEY ARE ALREADY IN CONTACT WITH EMBASSY.



3. COMMENT: DESPITE DIFFICULTIES MFA FORESAW IN  
OBTAINING REQUIRED DOCUMENT ON SUCH SHORT NOTICE,  
SPECIAL EFFORT WAS OBVIOUSLY MADE WHICH ENABLED PAVLOV
