1. THE DEPARTMENT APPRECIATES PROMPT RESPONSE TO ITS REQUEST FOR INFORMATION ABOUT WULFOWITZ' TESTIMONY AT ARAJS TRIAL. REQUEST WAS PROMPTED BY REPORT FROM HAZNERS' ATTORNEY THAT WULFOWITZ' TESTIMONY AT HAMBURG WAS INCONSISTENT WITH THAT WHICH HE GAVE IN U.S. (REPORT OF HAZNERS' ATTORNEY, MR. BERZINS, WAS BASED ON OBSERVATIONS OF SPECTATOR AT ARAJS TRIAL).
2. INS SPECIAL LITIGATION UNIT HAD ASSUMED THAT AN OFFICIAL RECORD OF WULFOWITZ' GERMAN TESTIMONY WAS BEING SUPPLIED IN RESPONSE TO STATE 319843, AND AGREED TO PROVIDE SAME TO MR. BERZINS. HOWEVER, STAATSANWALT KLEMM HAS SENT COPY OF HIS NOTES ON WITNESS'S TESTIMONY, WHICH INS WILL NOT RELEASE
