2. WALTER ADVISED US THAT HE UNDERSTOOD THAT AMCONSUL HAABURG WAS ALSO BEING INFORMED OF THIS DEVELOPMENT AND THAT HE THOUGHT KLEMM WOULD BE SPEAKING WITH INS OFFICIALS BY TELEPHONE TO EXPLORE THE ARRANGING OF A LATER DATE FOR HIS TRIP. STOESSEL
