KUZNETSOV REQUESTING EVIDENCE CONCERNING ALLEGED WAR CRIMES COMMITTED BY KARLIS DETLAVS, VILLIS ARNEDS HAZNERS AND SERGIS HUTYRCZYK AKA SERGEI GUTIRCHIK, PER INSTRUCTIONS REFTEL. AS IN PREVIOUS RESPONSES TO REQUESTS FOR SUCH EVIDENCE, TRIFONOV ANSWERED THAT REPLY WOULD BE FORTHCOMING IN DUE COURSE. EMBASSY POUCHING COPIES OF NOTE TO SCA AND EUR/SOV.
- 2. CONSULAR COUNSELOR ORALLY INFORMED TRIFONOV THAT INS ANNOUNCED OPENING OF PROCEEDINGS AGAINST BOLESLAV MAIKOVSKIS, BRONIUS KAMINSKAS AND KARLIS DETLAVS PER PARA 5 REFTEL. CONSOFF NOTED THAT EMBASSY HAS RECEIVED MATERIAL FROM MFA CONCERNING KAMINSKAS, HAS OUTSTANDING REQUEST REGARDING MAIKOVSKIS AND IN CURRENT NOTE IS REQUESTING MATERIAL ON DETLAVS.
