3. MOST FRG MATERIAL COME FROM CENTRAL OFFICE IN THE STATE OF NORTHRHINELAND-WESTPHALIA FOR THE PROCESSING OF UNCLASSIFIED

NATIONAL SOCIALIST WAR CRIMES AND CONSISTS PRINCIPALLY OF STATEMENTS THAT CENTRAL OFFICE HAD NO INFORMATION REGARDING INDIVIDUALS ABOUT WHOM EMBASSY HAD INQUIRED. HOWEVER, IN FIVE CASES CENTRAL OFFICE PROVIDED COPIES OF ITS RECORDS. INDIVIDUALS CONCERNED WERE: HAZNERS,

KARKLINS, LAIPENIEKS, MAIKOWSKIS AND WALUS.
