B. CONSULAR COUNSELOR ALSO ASKED TRIFONOV TO TRY
TO OBTAIN DATA ON ISRAELIT, PER REFTEL A, SO
THAT HIS LOCATION IN ISRAEL CAN BE TRACED AND HE CAN
BE REQUESTED TO TESTIFY IN MAIKOVSKIS CASE. CONSULAR
COUNSELOR THEN HANDED NOTES ON EACH OF THESE MATTERS
TO TRIFONOV, COPIES OF WHICH POUCHED TO DEPARTMENT.
